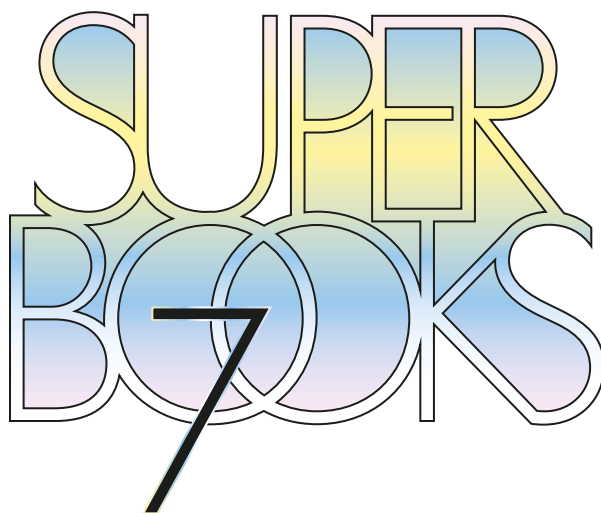

## Terms and Conditions

### Event Hours

Exhibitors will present their publications on 30.10.26 from 4 pm to 10 pm and on 31.10.26 from 12 noon to 8 pm in the Mittelhalle and Terrassensaal at Haus der Kunst, Prinzregentenstr. 1, 80538 Munich.

SUPER BOOKS 7 takes place on 30.10.26 during Open Haus, Haus der Kunst's monthly evening programme featuring free admission and a wide range of public events.

Set-up is possible from 2 pm onwards. The SUPER BOOKS team will also be on site from that time.

### Participation

Participation is only possible on both event days. Applications to exhibit publications without the exhibitor being present in person cannot be accepted.

### Eligibility

SUPER BOOKS 7 is open to publishers, artists and designers presenting multiple publications or editions produced in smaller print runs. The focus is on self-published and independently produced publications. Unique works and high-value artists' books are generally outside the scope of SUPER BOOKS.

### Participation Fee

A participation fee of EUR 60 applies for both event days. The fee is payable at Haus der Kunst ticket desk before the event opens on 30.10.26.

### Display Space

Each exhibitor will be provided with one white table (approx. 180 × 48 cm, height: 77.5 cm). Please note that dimensions may vary slightly. Additional tables, display cases or other presentation furniture are not permitted.

### Sales

Publications may be offered for sale during the event. Exhibitors are responsible for organising sales independently, setting their own prices and handling all transactions at their table. Haus der Kunst does not charge commission and has no influence on pricing.

### Selection Process

SUPER BOOKS 7 is a curated event. The curators will review all applications received by the application deadline (23.8.26), select the participants and allocate the exhibition spaces.

### House Rules

Exhibitors are required to comply with the venue regulations and House Rules of Haus der Kunst throughout the event. Rubbish and bottles must be disposed of in the designated bins and may not be left at the table.

### Changes to the Event

The organiser reserves the right to reschedule the event, change the venue or opening hours, cancel the event or end it early if necessary.

### Liability

The organiser accepts liability, regardless of the legal basis, for loss, theft, damage to property or personal injury arising during or in connection with participation in the event only where such damage has been caused intentionally or through gross negligence by the organiser, its legal representatives or authorised agents.

### Photography and Filming

By participating in SUPER BOOKS 7, exhibitors agree that photographs and video recordings made during the event may be used by Haus der Kunst free of charge, without limitation in time or place, for communication purposes, including press, publicity and promotional activities.
